So that my life, Art and work are recognized as a charitable asset.**

**Directly for the people upon the lands of Calgary, Alberta & Palliser's Triangle.
And indirectly benefiting the Crown and its subsidiaries, inclusive within the
Realm of Canada.**

What is the Art of "Actuarial Sociometry?"

The ability within the current economic parameters of 'time = money,' to predict cause and effect, in such a way as to display what conventional Actuarial science would prove by investigating and mining the After-Math known as result reporting. (or Metrics in common-business languages).

Through living modestly and sharing knowledge generously. Due to my unconventional path to learning the Art of "Actuarial Sociometry." I can live charitably, as an asset for the greater society, defined here as: **The People Upon the Lands of Calgary, Alberta & Palliser's Triangle.**

What I am seeking to do, as charitable work:

I seek to initiate, mediate and/or participate in discussions which are beneficial for all participating parties. So that middle-paths can create solutions and remedies for the aforementioned parties, and in direction for the common-good. To such a benefit as to, more than make up, for comfortably living a modest lifestyle. Consisting of: Food, Shelter, Clothing, Security, Personal Space (and a few comforts). And create impacts, while securing the peace between parties, that can be beneficial for the common-good of Calgary, Alberta & Palliser's Triangle.

This along with other 'Energy Work' endeavours, would be a charitable life-work and should be accounted for within the Income Tax Act.

So that modesty can lead the way in securing the same Food, Shelter, Clothing, Security and Personal Space for everyone as the first 'Bundle' of basic needs. As we 'basically need' this for society to evolve sophisticatedly and not revolve into history.

In this way, I am following the moral responsibility of meaningful labour. While progressing towards the luxury of being able to pursue my own happiness simultaneously, with the economy as the goals are aligned and my benefits or privileges shall only increase as the economy does. Yet, my right to live with 5 basic needs (and some comforts) will be guaranteed by society.

In this way, I will be foregoing the normal procedures for amassing great wealth at the expense of my neighbours.

I am seeking small amounts of capital, in order to establish a charitable fund. This fund will hold all of my artworks, except for my guitar music, as assets. For the purposes of appreciation and to be gifted freely to the community of supporters, where it is appropriate, to utilize in enabling themselves and their businesses, while indirectly benefiting the society at large. Through the reduction of debt and the removal of poverty upon the lands of Calgary, Alberta & Palliser's Triangle.

With the fund, I will be able to secure the 5 basic needs. Which allow any knowledge derived from the Art of "Actuarial Sociometry," as well as the tax benefits and societal grants, to be gifted to local business owners, operators and investors who seek to lift up the people in their organizations and the common people upon the lands of Calgary, Alberta & Palliser's Triangle.

This will be in perpetuity, until such time that debt and poverty issues are substantially satisfied. Privileges, once established, shall remain so long as all those who are partaking in the benefits; are sharing them as equally as possible and in a direction which removes the inequity that is harming the ability of our courts and other authorities. As to impede their abilities for doing the right thing for a prosperous society to find equilibrium on a people-basis.

This will be known as the generation of a common-wealth for the common-good of the people upon the lands of Calgary, Alberta & Palliser's triangle.

To provide clarity on who the 'people' are:

We are here for all those who reside, dwell, work or live upon the lands of Calgary, Alberta & Palliser's Triangle. For those who are traveling through, we thank you for not seeking to capitalize on our vulnerable sector and aiding us in restoring the most hurt among us. As we believe that:
"Hurt People, Hurt People. But Helped People, once restored, Help People."


It is our theory, based on the evidence of data about the economy and supplied by institutions of power and substance. That the real current direction, of the economy is harming the majority of people and that through "**The Art of Discussion,**" once displayed. We will be able to create both the velocity and containment necessary for all who are here to benefit from the guarantees of the 5 basic needs, in such a way as to allow the majority of people to wholly benefit each other, solely from the careers they currently have and wish to have in terms of passion and not through the causes of pay. As a profit-seeking mindset has caused many harmful effects. While a revenue generating common-wealth, restored for the common-good. Will find how to stabilize itself through interdependence and not reliance for 'wealth-redistribution.'

How a charity can fund-raise, without stepping out of the boundaries of the Income Tax Act?

References to sections are from the CRA's "Fundraising by registered charities Guidance."

What is Fundraising?

Any activity that includes a solicitation of present or future donations of cash or gifts in kind, or the sale of goods or services to raise funds, whether explicit or implied.



[**Solicitation:** 1. The act or an instance of requesting or seeking to obtain something; a request or petition.]

In kind means: any property other than cash.

As a rule: Asking for monies or property of individuals or companies.

Section D:

Applying for government grants.
Applying for other charity grants.
Utilization of Volunteers.




Direct Fundraising Activity:

- face-to-face, canvassing, telemarketing, major gift work with individuals, and direct mail;
- Events such as sports tournaments; runs, walks, auctions, dinners, galas, concerts and travel or trekking adventures;
- Sales of goods or services.

Indirect or related activities, such as:

- researching and developing fundraising strategies and plans or prospective donors;
- recruiting and training development officers;
- hiring of fundraisers; or
- donor-recognition programs.

As an activity, fundraising is not prohibited under the Income Tax Act. However, fundraising must still be carried out within the limits that the Income Tax Act placed on how a charity uses its resources.



Summary Statements:

All charities registered under the Income Tax Act are required by law to devote their resources to exclusively charitable purposes and activities. Although a charity can use some of its resources for fundraising to support the charitable activities that further its charitable purposes, it is the CRA's position that fundraising is not a charitable purpose in itself or a charitable activity that directly furthers a charitable purpose.

As a general rule, fundraising is any activity that includes a solicitation of present or future donations of cash or non-cash gifts, whether the solicitation is explicit or implied.

This means that a 'vibration = light' economy, which is simply a more sophisticated economy.

Can be derived from within a 'time = money' economy, solely by valuing time and money equally. Which currently does not happen, while we fight for minimum wage and other rights that are unproductive within an indebted society. As they are not concrete, due to fluxuations of supply and demand. This is the fact of debt, and not about the feelings of workers (who are due considerations, based on time).

Appendix C

Best practices a charity might follow to reduce the risk of carrying out unacceptable fundraising. These are recommendations and not requirements such as in section F.

Section F: You cannot fundraise when:

- the activity is the purpose of the charity (as that is a collateral purpose).
- the activity delivers a private benefit that isn't simply incidental, but is not necessary, reasonable or proportionate to the public benefit.
- the activity is illegal or contrary to public policies.
- the activity is deceptive.
- the activity is an unrelated business.

Section G: You may not be allowed to fundraise when:

- when the resources going to the fundraiser are more than what is going to the charitable activities.
- when rates of fundraising are at reasonable or market rates and does not alleviate concerns.
- when a charity makes use of non-financial resources, such as volunteers, a purely financial analysis of its operations [must document uses of non-financial resources].

GOOD EXAMPLE RULE:

A charity has a large number of volunteers who carry out its charitable activities on a day-to-day basis. The charity's cash income is relatively low, and it uses most of this money for its fundraising, and management and administration.

The charity's financial reporting on its Form T3010 will show relatively little spending on charitable programs. However, assuming the charity documents the use of its volunteers, such as by recording the number of volunteers helping the charity, how many hours they worked, and the activities they carried out, the charity will still likely be considered by the CRA to be devoting its resources appropriately

Must show time to make up for money. This example shows how to grow a charity.

'HIGHLY SUSPECT' EXAMPLE RULE:

A charity has a large number of volunteers who only carry out fundraising activities. The charity's cash income is relatively low, but it spends 100% of this money on its charitable activities.

The charity's financial reporting on its Form T3010 will appear to show it is devoting its resources entirely to its charitable activities. However, an audit or other review by the CRA will likely show that the charity is devoting a disproportionate amount of its total resources to fundraising.

CRA is calling this behaviour as 'highly Suspect.'

Appendix B:

To determine if an activity is exclusively, or almost exclusively, undertaken to fundraise, a charity must separate fundraising content from other content, and assess the:

- proportion of charitable, fundraising, and management/administrative content within the activity
- resources devoted to charitable, fundraising, and management/administrative content (employee and volunteer time, financial, and property)
- prominence of the fundraising content in the activity

"Modest Living" will alleviate the burden on any who are asked to account for this.

Appendix C:

As a rule, a registered charity's planned fundraising costs should be reasonable and proportionate to the type and scope of activity it needs to conduct to further its charitable purposes. Before undertaking fundraising, the registered charity should review:

- any regulatory obligations that apply to the type(s) of fundraising it is considering
- the costs and returns that can be expected based on the types and scope of fundraising it is considering undertaking
- other potential fundraising methods

The War on Equity:

How local business, can work together, and free our authorities from the debt or inequity which is preventing justice from equal application, of law upon all.

On the matter of Homelessness:

It can be inferred that most people who are in the homeless class did not plan or desire to be in this category.

However, it is the case, that before technological advances allowed for common purchases outside of our borders.

That homeless people, sustained the economy, due to the fact that their purchases were (and typically still are) contained locally.

The removal of the penny has resulted in store clerks, charging in measurements of 5 cents. Whether rounding up or down.

The automated transaction machines however, will still capture payments of 6, 7, 8 cents and the like.

This means that the large removal of coins in circulation, has removed some of our local society's ability to keep more of the money local.

And it is evidenced in the knowledge that more housing assistance is needed then in the past.

We do not simply have a population issue. It is a supply and demand issue.

The Government will increase the supply:

As has been seen in other nations. The housing issue, which is one on a spectrum of 'subtle to excruciating' greed, due to the education surrounding good debts and bad debts. Which have increased the amount of landlords who solely seek profit; regardless of their tenant's needs or comfort.

This is due to a, training of the eyes, whereupon people are seen within diversified portfolios.

And has effected the situation to such a great degree that the government and/or other powers will increase the supply of houses.

This will utilize more land, which the CRA determines cannot be depreciated. While it is the case, as we've seen, that the housing

market can cease to appreciate and sometimes will reverse in appreciation. This method ensures that equity will be lost, through inflations that are spread out so as to create an easement on the overall situation. Those in the market will be fine, except for a few who fall

between the cracks of a buying and selling cycle, although the rigidity of the real estate structure will hold.

So long as unethical practices such as 'double-ending' are dissipated. And unjust burdens are remedied.

Those who have lived modestly, with the increased equity derived between approximately 1994 - 2018, will also be fine.

However, those who continually sponsored more luxurious lifestyles, or who increased their debt disregarding the good or bad labels, which financial advisors or analysts have placed on the terminology.

These individuals and groups will begin to lose not only equity but actual property without the assistance of friends, family, or the overall society.

Directions for Municipalities:

If the consumer mindset continues in the manner it has for the past 3 decades. Than we will continue to generate more homeless people, while at the same time having many people-less homes.

In this way, and by the 'De facto' nature which any legal system, must operate in, so that it can become common law or custom, upon the land.

The municipality and the people will lose many operating and emergency abilities, as the wealth will be drained by foreign investment which must recoup any expenses which were made for the goodwill of our people. As the stockholders demand fiduciary responsibility from corporations.

Should our municipality look to provide the **5 basic needs of: Food, Shelter, Clothing, Security and Personal Space**, to the people who are here.

They will be able to appreciate the land, thereby generating real interest and real demand within the housing and/or land market once again.

And equity will find its equilibrium due to a charitable disposition within our economy.

This is What is meant, by 'The War on Equity:'

And it is why the CRA is asking, through their rules on claiming tax benefits and exemptions to use Art through charitable means.

However, too many individuals and groups have used these supposed 'loopholes,' in ways that further greed. While diluting charitable impacts.

And it only takes a few to get away with it, for others to begin following. As people feel ripped off, when others seemingly

get benefits they themselves don't. If businesses, actually partnered with Artists and skilled labourers for the common-good.

Taxes could be accounted for and administrated authentically. And this would lead to a populous that pays off the debt, and not solely the interest of the debt-holders. The tax laws are not the issue, we the people are.

And it starts in the middle-class as they are the only ones with both the time and the money, to get the economy 'vibrating' in the right direction.

So that it no longer weighs people down into depression, but becomes something much more friendly and 'light.'

Why there is a basic need to stimulate local business:

Once the public sector is subsidized through local business and not largely big box group benefit plans. The local populous will be able to re-venue funds much more quickly than the government and can thereby assist public sectors such as mental health and the like, in researching, developing and ultimately healing our people as they make better choices for trades and futures. This local focus is a mutual benefit for all here. Once resources are aimed at our issues and have resolved them. Proper trade relations dictate that we will be able to spread good outwardly, for healing purposes. This will bring a "Peace of Equity," and the larger justice issues of equality can be minimized by the local populous for the common-good.

The Following entities will be utilized for accomplishing the end goals of reducing and removing both debt and poverty. Not solely through my own work, but also an education of sorts towards, 'upgrading the citizenry.'



Below are some of the things which the entities and myself will seek to do:

- Establish guidelines and best practices for local business to find advantages over big box stores, with the benefit for the common-good being derived from a greater recirculation of currency and overall work-energy.
- Reduce individual time commitments through the shared use of technology, as to not allow the machines to take jobs without residual benefits going to those who have been replaced.
- Create interest and demand in local business through: Resource Sharing; Insurance Credit Pools; Talent Exchange; Anchored Thought Tanks; Debt Solutions Specialties; Training; Research & Development; Securitization of Workspaces; Establishment of Discussion Houses; Stabilization Through Trades.
- Creation of local incentives in order to create a small separation for a greater impact being provided through tourism.
- Creation of local Economic Tours, driven through customer learning. This and other attractions will be utilized to bring the attention, currently on world focuses back to our lands.
- Local businesses will be encouraged to form partnerships with the professional class in such away as to re-establish the lost bandwidth within the minds of local people, so that proper discussion and its derivative values (such as negotiation), can be restored.
- Create pathways for restitution on the part of wrong-doers to go almost solely to restorative centers in order to further the law of "Hurt People, Hurt People. But Helped People, Once Restored, Help People."
- Secure the peace, through non-disruptive methods of attacking franchises, multi-level marketing schemes and other legal instruments which are hurting our overall economy. But in such a way, as to transmute and not harm local franchise owners, operators and investors. While ensuring good trade relations. As we seek to establish real business ownership, so that it can become pervasive and remove the current corruptive structures, which are controlling our supply chains and other logistical operations.

I myself will seek to adhere to certain principles as to limit my capacity to misuse funds, either by accident or acts of will and intent.

'Privated amongst the public.'

I will seek to live, reside, dwell and work in the homes or offices of people. So as to not use monetary funds for the 5 basic needs. Should they be met, the Host who is capacitated in the role of a provider, shall receive the following:

- Taxable benefits derived from operating a Head Quarters of sorts, in their home. [Percentage of home being used for a charitable business].
- Reduction through tax-savings in the amount of purchases towards food, clothing and shelter. [receipt deductibles]
- Benefits towards building their own doorway to the 'vibration = light' economy, with an exacted bias, as they are Hosting and should benefit from time saving opportunities, while working towards individual passions that would benefit the common-good.

'Personal Protection Escort'

As it is the case, that mental health is not only important but an issue which seemingly effects all within a depressed economy. Some of the comforts utilized such as storage space and legal substances. Will be purchased by trusted supporters who are within a **Personal Protection Escort**. And while not always being next to me physically, look out for my well-being. The following benefits will be claimable for any who seek them:

- When purchasing like products, in terms of their own needs and my own, which they are granting to my mental health. Any taxable benefits resulting from this gift towards PPE, shall extend to their own purchase when made simultaneously. This so that, overuse by those who are not under my command or control, is stifled even before it could be seen as negligence or abuse of the reciprocating benefit.
- Similar, benefits for taking up space, through those who provide storage for items utilized in furthering the fund and charitable work, will be applied as an easement to the space costs, which these people or businesses have taken on in an effort to spread this charitable work.

'3rd party maintenance'

Wherever possible, which should almost be always, once the 5 basic needs are fully guaranteed. I shall maintain a 3rd party role with all businesses or organizations, which I am assisting or who are assisting myself. In this way, it will be known that advice is freely given and not to be confused with any connotations of the term "Free Advice," "Legal Advice," or the like. In this way, I will be saving the fund time, by setting up action plans, training the trainers, and not fully committing to completing the work involved past creation of strategic action plans for the business. In this way, the skills will be learned experientially and this new found wisdom will be for the people in the business to share with other locals, where they see fit. I will also be able to encourage all to share the wealth, so to speak. As through the conveyance of knowledge amongst the local populous we will be able to decrease the length of time needed to reach the goals of reducing the debt and removing poverty upon these lands.

Preference towards lines of credit or credit lines

While cash donations, may be a way of fund-raising. I will seek to ensure all of those, go towards charitable endeavours, geared towards our vulnerable sector, so that immediate relief can be actualized. In terms of operating costs and functioning requirements I will seek credits over debits and other monetary instruments which are derived from debt. With a note of recognition, that this is hard to escape when the city, province and country upon these lands is itself in debt and currently running high deficits. The benefit to the provider, will both be seen though the transactions as receipts will be copied and go to them, so that they can verify expenditure claims with the CRA. Any points, derived from these expenditures, which accompany the cards of credit themselves, will be 100% recoup-able by the provider.

Wherever and whenever other opportunities or methods are found for benefiting both supporters of the fund and the common-good. So long as they fall within the scope of the CRA and the Income Tax Act. I will seek to implement and utilize these measures on behalf of both protecting the fund and increasing support for the local populous.

Miscellaneous

Start then learn: It is the case that without any assurance or secured benefits that I have already begun to walk this path and do this work. Although it is now becoming common for the entrepreneurial spirit to take hold. I have been working towards this endeavour for the past 13 years, as it takes time to become capacitated in the Art of "Actuarial Sociometry." As the scope of this work encompasses the entire economic system, specifically for Calgary, Alberta & Palliser's Triangle. However, a need for understanding the larger economies of nations and the world, while at the same time discovering the economics within individual companies, homes, families and other groups is necessary. As one must work within the binary framework of 'All and Nothing' simultaneously. The expense was necessary due to limitations of education and other resources.

Incurred expenses: This endeavour has left me with limited resources. Not only in monetary terms. I have strained and even lost countless relationships. Real Property and have had to endure offenses upon my name and personal character. Since fully beginning this work, less than two years from this writing, I have lost over 50 pounds from my bodily frame. Not due to diet restrictions, but solely to the fact that food was not always readily available, as I followed the path laid out in Charles Bukowski's poem "Go All the Way."

Why it will succeed with support: It is the case that our current society, while labouring and doing work. Is, through no fault of their own, toiling towards increasing debt loads, which once broken will cause a greater deal of poverty. "History Is Not Our Fault, But The Future Is" was a digital mural, along with others that I created over a year ago, for attempting to explain our systemic issues by way of graphic design. If the Art and my own life, which can not be separated at this point, are appreciated, the people upon the lands of Calgary, Alberta & Palliser's Triangle will find a reversal of fortune. Both colloquially and Economically speaking. So that prosperity may guide us on the path of Providence and not the one to ruin which is currently provided, although cleverly hidden from the senses of the common-mind.

How the CRA's position is in line with this Undertaking: The CRA and also the Bank of Canada itself, have been encouraging through reports, illustrations and the aforementioned 'loopholes.' For individuals, and groups of all size and classes to support both local and art. As they are aware of the containment issues of our economies, as well as the dangers of a consumerist mindset. One which is driven primarily from media attacks, akin to propaganda but often labeled as advertising, from companies that are not only foreign, but are not seeking to provide reciprocal benefits to our people. Therefore, a person whether real or imagined, that is working to alleviate debt burdens through charitable means, is aligned with their goals of a prosperous nation. The CRA recongizes the importance of creativity and how limited that resource is.

Protecting the fund: It is the case that many people have already offered support where they can in relation to the 5 Basic Needs and comforts of mental health. In order to protect the fund, and its charitable work. All people are invited to support. However, trust is the only mandate followed. Any family, friend, co-workers, acquaintances, or other statuses held within my own sphere of recognition are always secondary to the mandate of trust needed to accomplish the work. Therefore, all cash donations, were gifted to others who were in more unfortunate circumstances, during these past two years. Any who support this and are currently in debt, whether 'good or bad debt,' will benefit from following the modesty approach by being able to pay down their debt quicker, so that a doorway into the 'vibration = light' economy can be sustained for them to follow.

What do I mean by comforts: While very limited. Anything that falls within the legal boundaries of the Law Society of Alberta, and the practices of the AGLC, so long as a receipt can be provided. And are used for securing my own mental health, would qualify as comforts. Moderation is expected. For those, who are discomfited by the use of substances prescribed under the AGLC. It is widely-known that many of the individual costs associated with purchasing these items, goes towards funds directed at supplementing the Healthcare system. Whereas, a disease such as obesity, is not often accounted for through purchases and the rate to which it effects the organs such as the heart, is ignored. With Heart failure, being the leading cause of death for decades now. Therefore, it is my assertion along with many other individuals, that commonly accepted products and consumables are often more of a burden on the healthcare system when abused. And this must remain an assertion or inference only, as the proper statistics and data have not been quantified in such a way as to account for their contribution, to our public burdens.

Why I am protecting my guitar art: It is the case, that my graphic designs, spoken word, the "Art of Discussion," and business acumen will be used solely for charitable work and the fund itself. However, it is also the case that private ventures which operate upon these lands do so for profit over revenue. And even within the public sector, funds often cannot be 're-venued appropriately,' as various sectors fight for budgets. In order to prove to creatives and Artists, that their is a path for sharing things such as royalties, while maintaining enough for oneself, it is my discretion to protect a portion of my art. So that retirement plans, pensions and other sort of dream-saving measures can be derived whilst allowing the public to benefit from most of my own creations. As it is the case that much of the motivation for an Artist resides within their ability to have control over their own creative direction. And my discretion is used as a protection towards my own mental health, as the creative process is not without its own tolls, upon psyche.

Why I am doing this and what is an 'energy worker:' As a person who walks with their Heart-Mind, capacitated over their Thinking-Mind. It pains, me to see the depression signs of economic weight upon the faces and in the lives of all who I meet in these lands. Although to varying degrees. Thus much of my personal satisfaction, is derived from the satisfaction of others. An energy worker is someone who can read the electromagnetic spectrum, for the proximity around them and through various developed faculties of the senses. They can tell when energy is being depleted within a being and where it is happening. They can provide advices and remedies for restoring this energy. They can also show individuals, couples or groups why they should and how they can protect their energy, while also seeking to share it in reciprocal ways with all the "others," who they come into proximity with. Either physically or by way of communication and attention. Energy work, leads to Light work and is the goal for all who are on this path.
